# **Legislative Update**

The current National Pollutant Discharge Elimination System (NPDES) permit has expired. However the current permit will administratively continue and remain in force and effect until the Ohio EPA issues a renewed permit. So if you were authorized to discharge under this permit prior to the expiration date you will automatically remain covered by the expired permit. A new permit should come under public comment at some point, but to my knowledge there has been no movement on a new permit.

# Mosquito Surveillance

The Ohio Department of Health will again be providing mosquito identification and West Nile Virus testing this year. Mosquito traps, sample tubes, coolers, shipping labels and other supplies are available to surveillance partners free of charge. Mosquitoes can be submitted starting on May 16th. Detailed instructions will be emailed to all local surveillance agencies.

Weekly surveillance updates will be posted at https://odh.ohio.gov/vectorupdate.

#### **Tick Surveillance**

ODH also accepts ticks year-round for species identification (the CDC does not recommend testing host-fed ticks for disease and ODH does not offer this service). Updated submission forms are available, as well as sample tubes and padded envelopes for shipping. Local agencies are encouraged to conduct active tick collections within their jurisdiction.
